Pastor is going to do some more inquiries on the insurance options and the appraisal.			
	We may go into a different direction with the elevator for the upgrade. We learned there may be an option for a standalone unit that would still provide our needs for an elevator as needed. The only obstacle would be it would not go to the basement. Would only serve sanctuary floor and first floor. If we go this option, we would not need to repair/replace the current older elevator system. Mike Jones is exploring the option. Estimated cost is \$49,000 which we believe is a base cost. Shawn will continue to update us.
